

NATIONAL TRACK PLAYER/PARENT AGREEMENT

This player/parent agreement (“Contract”) is made between Oceanside Pop Warner Organization and _____ (Print Player Name), _____ (Print Parent/Guardian Name) On this ____, day of _____, 2024 . The Oceanside Pop Warner Organization and player and parent, in consideration of the promises of each to the other, agree as follows:

Attendance:

Every effort should be made to attend all practices and games and be on time. If you are running late, please reach out to your team Business Manager. Parents shall be solely responsible for ensuring that the player is transported to and from all practices and games. If a player misses a practice, he/she should not “expect” to start the following game, though, he/she may. The coach reserves the right to make this decision at his/her discretion.

Attendance of Friends/Parents

Parents, please refrain from coaching your child on the sidelines. Please be courteous to the coaching staff and allow coaches to coach. Outbursts and disruptive behavior from the parents, fans, and players will not be tolerated and any such actions may result in removal from team. Parents are encouraged to support their children. However, during practices and games they should refrain from approaching the sideline to coach, counselor, or to critique their child.

Conduct

Good sportsmanship and professional behavior is expected at all times, and in all circumstances by both the player and the parent. There should be no conversation with referees, coaches or players regarding a call or a play. We will not tolerate disruptive behavior on the field or in the stands. Oceanside Pop Warner reserves the right to dismiss any player or parent who breaches good sportsmanship or ethics at its sole and absolute discretion that it determines are contrary to the best interest of the Organization.

Fundraising

Fundraising is a key source of revenue vital to covering major expenses for your national team travel and end of season celebration. There will be a value placed on each fundraiser that each player will be responsible for. It is mandatory that all players and parents are expected to participate in not only team fundraising activities, but also individual fundraising efforts. Oceanside Pop Warner reserves the right to decline National Team Participation for future seasons if fundraising efforts are not met by both Player and Parent in the 2024 season.

Financial Obligation:

It is important to be reminded of your financial obligation on a national track team and ensure that every effort be made to secure your child’s National travel expenses prior to November 8, 2024. Estimated national travel expense is \$2,000 per player. *A seventy-five-dollar player protection fee (PPF) will be due once the player has accepted his/her position on the team, no later than Aug 1, 2024. If this payment is not made in full, the player will not be allowed to certify on the National Team.* All checks should be made payable to Oceanside Pop Warner and will be deposited into the appropriate team account. A returned check fee of \$35 will be charged for any dishonored check.

Estimated Expenses for **National Championship Week in FL (Dec 7 – Dec 14)**. Players are expected to be ready to practice Dec 7th. Players need to arrive Dec 6.

- \$525 Pop Warner Football Package
- \$150/Night for Budget Hotel Bracket
- \$350 Round Trip Flight to Orlando, FL
- \$450 Food (\$50/day for 9 days total)
- \$100/Day for Rental Car

The parents agree to accept the above financial obligation and accept the responsibility to cover the balance required after fundraising efforts for your child to participate in the National Championship week.

Injuries/Insurance:

In the event of an injury, if possible, the player should still attend practice. Much can be learned from helping coaches and listening to practice. If the player becomes injured or becomes ill during a game or practice, it is their responsibility to report it to a coach immediately. Parents shall maintain medical, health, dental and accident insurance for the benefit of the player.

Addressing Concerns/Problems:

The parents agree to not bring up concerns during and after a game or in the middle of a practice. Parents should call the Team Mom, Business Manager or Coach to set up an appropriate time to address questions or concerns.

Rules and Expectations

The player and parent agree to accept, abide by, and comply with all provisions of the Oceanside Pop Warner Bylaws and rules. Use of tobacco products, and consumption of alcohol and/or drugs is strictly prohibited by parents and players at any organized activity associated with Oceanside Pop Warner.

Marketing

The player and parent agree that his/her picture may be taken for still photographs, motion pictures or social media sites. Still photographs and motion pictures may be used by the organization, coaches, and staff for publicity and related advertising purposes in any manner it desires.

We have read, fully understand, and agree to abide by each, and every item and condition set forth within this player/parent contract.
